3. Only one application is allowed for each teacher in a single school year; each school/kindergarten can submit no more than two applications in a single school year.
4. For Chinese research reports, please complete this form in Chinese; for English reports, please complete this form in block English letters. Please note that the application form shall be typewritten; handwritten forms will NOT be accepted (save for the signatures).
5. Please attach a separate sheet if the space provided below is insufficient (not more than ONE A4 page).
6. Research groups with accepted proposals should submit their research reports by 31 August 2026.
7. The copyright of accepted research reports will be owned by the Secretariat of the Working Group on the Educational Research Award Scheme under the Committee on Professional Development of Teachers and Principals (COTAP).

### Purpose of Collection
